Permit authorized construction of a new 100-foot-tall (above existing ground level - AGL) telecommunications tower, with the top 35 feet concealed as a simulated pine tree. The total height of the simulated tree tower is 110 feet (100-foot tower plus 10-foot crown branch). The permit further authorized: AT&T Mobility - Upstate NY installing nine 8-foot-tall panel antennas on the tower (at a centerline height of 100 feet AGL); and St. Lawrence County Office of Emergency Services installing one 5-foot-tall whip antenna to the top of the tower (total height 105 feet AGL).
