Brief Description of Proposed Action (include purpose or need): NYCO Minerals Inc. intends to explore the mineral resources located within and under a parcel of land located adjacent to its current mining operations. The parcel "Lot 8" was the subject of a successful statewide referendum that permits the State of NY and NYCO Minerals to explore the mineral potential of this specific parcel of ground. If significant mineral reserves are discovered, the referendum allows the State of NY to consider the exchange of this parcel for other valuable land blocks or other consideration. Lot 8 is believed to be host to an extension of a wollastonite deposit currently mined on an adjacent parcel of ground. In order to verify this belief, NYCO proposes to diamond core drill the parcel to the ultimate depth of the mineral bed (but not deeper than 400 feet from the surface). This will require the development of a network of access corridors through the forest covering this lot and developing small clearings in which to set up a drilling site. Attached is a map showing the locations of the proposed test holes and the access corridor network to access these drilling sites.



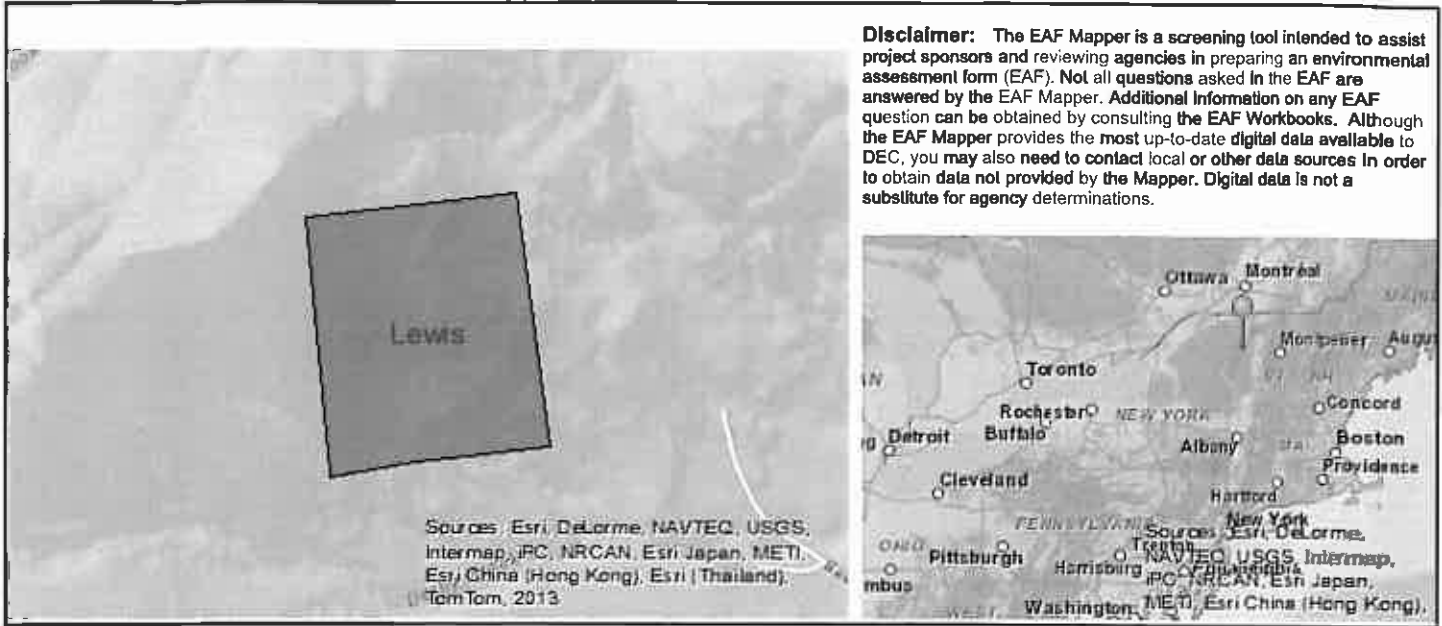
