This proposal does not include any additional extracting of minerals from the existing bedrock face, but does allow for a test blast to be conducted for the purpose of determining a baseline for which the remaining unconsolidated material may be removed. Additional removal of unconsolidated material over and above the existing stockpile will require further Agency review and approval. The proposed mining operation will operate year round, Monday through Friday, 7:00 a.m. to 5pm and Saturdays 8:00 a.m. to 2p.m. No processing of material will take place on Saturday. The equipment to be used in the mining operation includes front-end loaders, bulldozers, dump trucks, portable screener and crusher. Maximum number of truck trips per day is 50, average per day is 8.
