### 5. Monthly Report of Executed Settlement Agreements:

**Nine** enforcement cases were resolved by settlement agreements executed in **June**, **July**, **and August 2018** as follows:

### E2018-0010, Huestis Living Trust, (Ticonderoga, Essex County)

Subdivision involving more than 10 lots or sites in Low Intensity Use in 2015. Settlement recognizes the site as lawful, allocates principal building potential, requires a permit for future subdivision or construction of a principal building, requires Agency review of future onsite wastewater treatment system replacement, places restrictions on exterior lighting, and requires filing in the County Clerk's Office.

## E2018-0040, Ferguson, (Dresden, Washington County)

Subdivision involving more than 5 lots in Rural Use in 2016. Settlement requires merger of the lot with an adjoining property and filing in the County Clerk's Office.

#### E2018-0007, Eddy Foundation, (Essex, Essex County)

Conversion of pre-existing structures to semi-public buildings on Resource Management lands in 2006. Settlement recognizes semi-public buildings as lawful, requires Agency review of any future expansion, and requires filing in the County Clerk's Office.

#### E2018-0029, Stonach, (Black Brook, Clinton County)

Subdivision involving wetlands in 2016 without a valid Agency permit. Settlement recognizes property as lawful, requires a permit for any future subdivision or construction of a principal building, and requires filing in the County Clerk's Office.

#### E2018-0042, Hamblin, (Thurman, Warren County)

Construction of a single family dwelling and onsite wastewater treatment system in 2007 in noncompliance with Agency Permit 2005-209. Settlement recognizes dwelling as lawful and requires Agency approval of any future expansion, requires replacement of the onsite wastewater treatment system, and restricts color and lighting associated with the dwelling. Settlement must also be filed in the County Clerk's Office.

#### E2018-0056, Mulcahy, (Fort Ann, Washington County)

Subdivision creating a substandard-sized lot in Rural Use in 1973, and construction of a dwelling on a lot with substandard shoreline lot width in 1975. Settlement recognizes property and dwelling as lawful, requires Agency approval of any future expansion of the dwelling, allows for construction of a garage on the property, requires Agency review of future replacement of the onsite wastewater treatment system, restricts lighting, and requires filing in the County Clerk's Office.

#### E2018-0061, Madtes, (Webb, Herkimer County)

Construction of a single family dwelling on Resource Management lands within a recreational river area in 1988. Settlement recognizes dwelling as lawful, allows for an expansion of the dwelling, requires replacement of the onsite wastewater treatment system, and requires filing in the County Clerk's Office.

#### E2018-0089, Debbiedo, Inc. (Saratoga County)

Subdivision involving wetlands in 1989. Settlement recognizes property as lawful, allocates principal building potential, allows for construction of a single family dwelling, requires a permit for future activities involving wetlands, and requires filing in the County Clerk's Office.

#### E2018-0027, Foster (North Elba, Essex County)

Construction of a cabin within 1/8 mile of the Sentinel Range Wilderness Area in 1995. Settlement recognizes cabin as lawful, requires Agency approval for any expansion or installation of a new wastewater treatment system, restricts lighting, color, and vegetation removal, and requires filing in the County Clerk's Office
