Brief Description of Proposed Action (include purpose or need): The Adirondack Park Agency (APA) proposes to amend general permit P2014G-0001A which is currently used for the management of terrestrial invasive plant species in or within 100 feet of wetlands. The permit is to be issued with conditions authorizing the management of terrestrial invasive plant and non-plant species in or potentially impacting wetlands within the Adirondack Park. Terrestrial invasive species have demonstrated severe negative effects on native wetland systems including loss of habitat, negative changes in hydrology and nutrient cycling and loss of biodiversity. This general permit will allow certain trained experts to implement management activities to eradicate or reduce population numbers or otherwise control the growth and spread of terrestrial invasive species in wetlands within the Adirondack Park. This permit amendment expands the treatment of terrestrial invasive species to include non-plant species in addition to plants in an effort to enable treatment for species new to the Adirondack Park, including but not limited to Hemlock Woolly Adelgid (<i>Adelges tsugae</i>). This permit amendment also expands the areas subject to the permit to include management actions in or potentially impacting wetlands, instead of limiting the permit to areas in or within 100 feet of wetlands. This change aligns the permit with the Agency's jurisdiction over wetlands projects.
