General Permit 2014G-1

- GP2014G-1 approved by the Agency in April 2014
- Users named in GP may conduct management of terrestrial invasive plant species
 - DOT, DEC, Adirondack Chapter of the Nature Conservancy (APIPP), Regional Inlet Invasive Plant Program (RIIPP)
- Facilitated invasive plant management in the Park

General Permit 2014G-1A

- General Permit 2014G-1A was a **reissuance** of General Permit 2014G-1 (June 2015)
- Named users do not have to seek a permit from Agency for each specific project
- Must undertake work in compliance with BMPs and other conditions in GP
- DOT, DEC, APIPP, RIIPP were still named users
- Interested persons apply to become eligible to use GP2014G-1A through the *Application to Use General Permit 2014G-1A to Manage Terrestrial Invasive Plant Species*.
- Enabled the DDRP to certify additional qualified applicants and maintain a list of Authorized Users
- Required annual reporting
- Authorized Users not in compliance may be removed from list



Applicant Certification

- Application also contains an Applicant Certification to document **Qualified Representative**
- Requires applicant to be responsible for complying with all of the permit conditions in the GP and ensuring the applicant's qualified representative complies with all conditions
- Must have experience and training in the identification and management of terrestrial invasive plant species
- If applicant is approved to be an authorized user and their named qualified representative changes – must reapply.

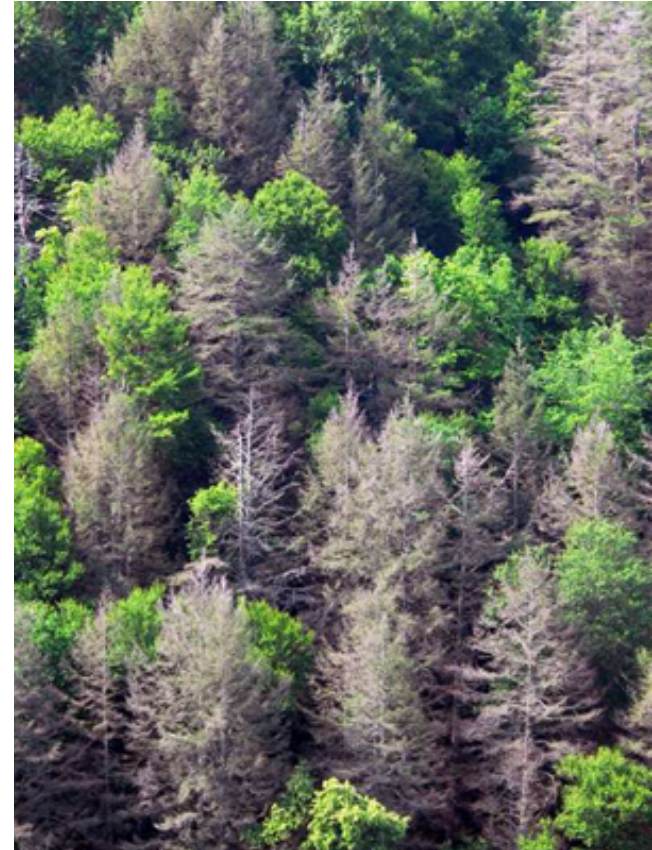
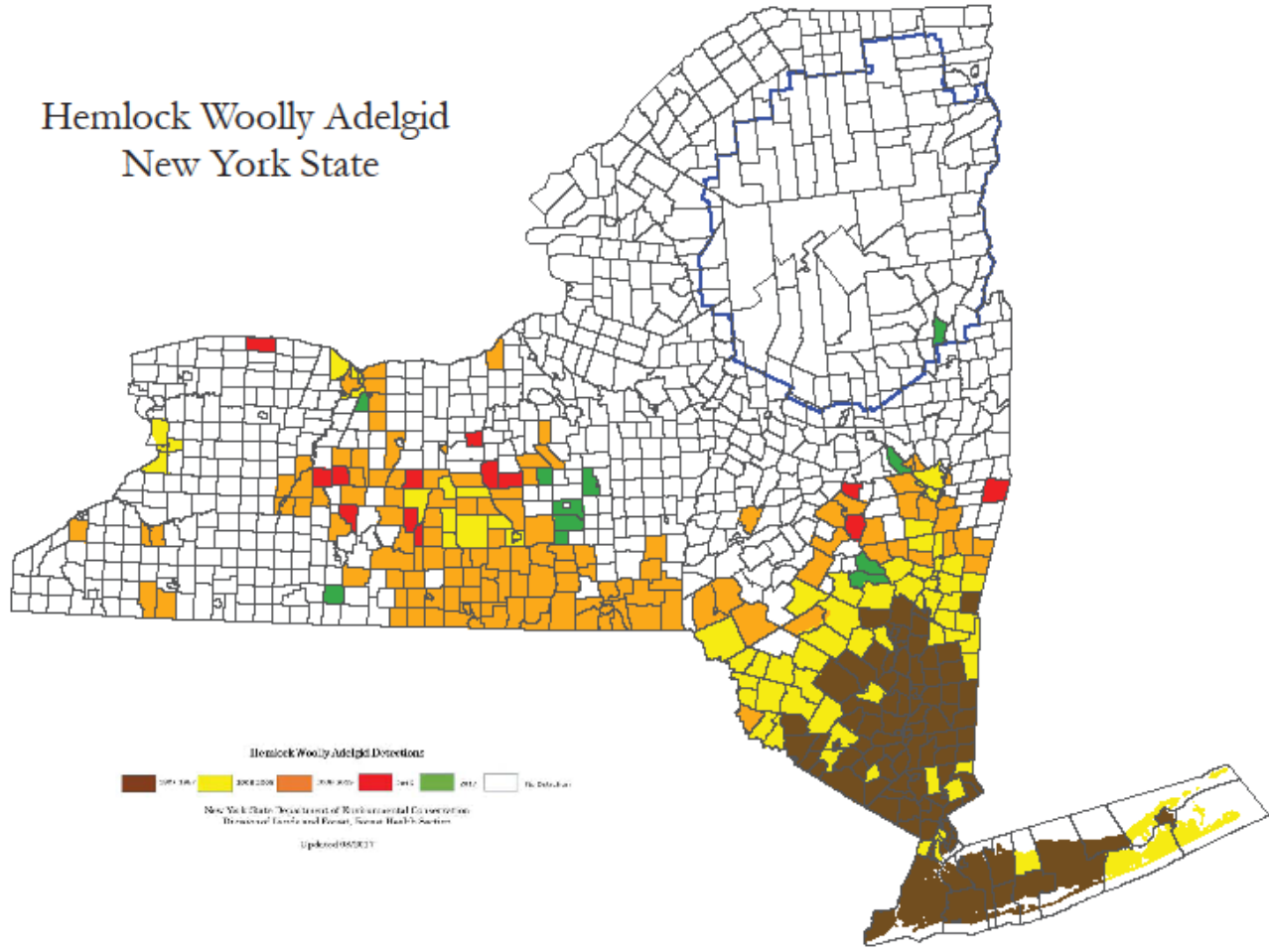
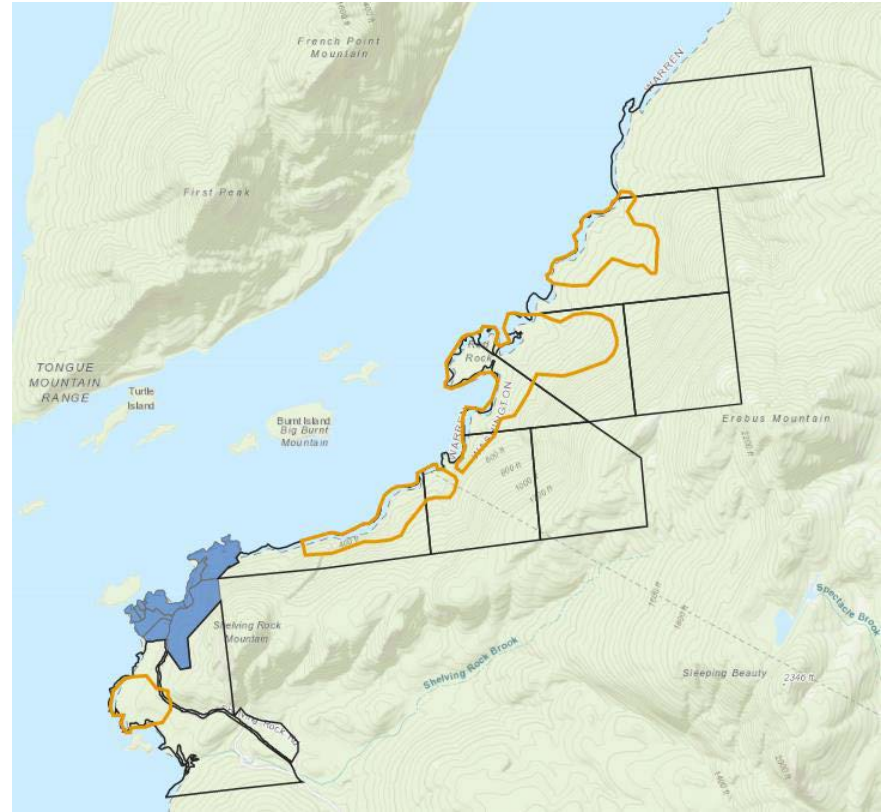

SUMMARY AND AUTHORIZATION

Pursuant to Environmental Conservation Law (ECL) Article 24, Executive Law § 809(13)(e), and 9 NYCRR §§ 572.23 ~~and 578~~, this general permit authorizes the conditional undertaking of regulated activities incidental to the management of terrestrial invasive ~~plant~~ species in or ~~within 100-feet-of-potentially impacting~~ wetlands in the Adirondack Park by authorized users through the use of management activities intended to eradicate or reduce population numbers or otherwise control the growth and spread of terrestrial invasive ~~plant~~ species.

The Deputy Director of Regulatory Programs (DDRP) shall maintain a list of Authorized Users approved to use GP2014G-~~1A1B~~ (~~Authorized Users list, separately identifying persons authorized to undertake management of invasive terrestrial plant species and persons authorized to undertake management of invasive terrestrial non-plant species. For purposes of this general permit, the term "person" shall have the same definition as in 9 NYCRR § 578.3. Organizations Persons not named in General Permit 2014G-1A 1B~~) will be added to the ~~Authorized Users~~ list through the DDRP's approval of the ~~Application to Use General Permit 2014G-1A-1B-to-Manage-Terrestrial-Invasive-Plant Species In or Within 100-Foot of Wetlands in the Adirondack Park~~. Authorized Users not in compliance with the conditions in this general permit may be removed from the ~~Agency's GP2014G-1A-1B~~ Authorized Users list at the discretion of and upon notification by the DDRP.

~~This general permit is issued to the New York State Department of Transportation (NYSDOT), the New York State Department of Environmental Conservation (NYSDEC), the Adirondack Chapter of the Nature Conservancy, the Adirondack Park Invasive Plant Program (APIPP), the Regional Inlet Invasive Plant Program, and other authorized users as designated by the Deputy Director — Regulatory Programs.~~ All activities undertaken pursuant to this general permit shall comply with the conditions in this general permit.

This general permit shall be in effect from the date of issuance unless otherwise modified or revoked by the Agency.

General Permit 2014G-1B

- Allows the management of terrestrial invasive species
- No longer list specific user names
- Changed the reporting requirement date
