#### 4. Executive Director's Report

Terry Martino reported on the increases in the jurisdictional inquiry requests which totaled 1128 at the end of October, sixteen above the 1112 total for all of the 2020 calendar year, and reported that program data in the other divisions will be finalized in activity reports at the end of the year. Staff hiring for Corrie Magee, Environmental Program Specialist 3 and Alexis Sandiford, Office Assistant 1, were announced. Terry Martino commended the staff team who worked together regarding the solar presentation on the Board agenda.

#### Public Comment

On motion of Dan Wilt, seconded by Ken Lynch, the Agency unanimously approved P2007-0320R3, Saverio Ruffolo, third renewal of Permit 2007-0320 which authorized two lots involving wetlands in an eight-lot subdivision. Lot 1 is currently developed by a pre-existing single-family dwelling and the other lot is proposed to be improved by a subdivision road to be used as access to Lots 2-7.
