Dear sir,

The St. Regis Lakes are the best preserved lakes in the Adirondacks and we intend to keep them that way. We initiated the boat wash/inspection program, along with the PSC Watershed institute, in the Park and now have purchased/installed/manned a state-of-the-art heated, pressure wash piece of equipment to ensure we keep the lake free of invasive species. This has been enabled by extensive funds we have paid from our property owners, along with cost of the attendants.

The architectural appearance of the shoreline has been maintained by responsible property owners who relish the unique character of the structures and intend to keep that in mind when building. We also continue to encourage the upgrading of septic systems and have been successful in decreasing pollutants in the lake.

This project proposed by the Hawkins, is a prime example of a neighbor wanting to erect a necessary addition to a boathouse that was compliant when it was built, now labeled non-compliant, with a design that is barely noticeable. The immediate neighbors, and those across the lake, support the project unanimously. There is always a resident that has built out all they need that resists any future building by others as I detect is the issue here. We are also swayed, in encouraging your approval, that this structure is being built for a restored relic, powered by an electric motor, rather than an oversized, overpowered launch that will be a severe detriment to the environment.

We encourage the APA to reconsider their negative ruling against this now down-sized addition that we very much approve. I am sure a site visit will show your group that this is the best alternative for this needed addition.

## Mr. Haralson,

I own the camp next to the Hawkins camp on Spitfire Lake. I have addressed my concerns to the APA in the past and this email will express my continuing concerns about the need to approve their request for the variance requiring your approval to construct a one slip addition to their existing boathouse.

I am a retired architect and have summered on Spitfire Lakefor well over thirty years . The summary of my thoughts are:

- 1. I am 100 percent in favor of permitting the single slip addition.
- 2. I am 100percent against the allowed construction of a new 60' flat roofed singleslip boathouse.

That solution would be the focus of the view from my camp and would project at least 60 feet into the lake. The flat roof seems an odd choice to consider in the Adirondack climate and aesthetically creates an industrial appearance, totally out of character with all of the Adirondack style buildings we All admire. Due to the very shallow water in that proposed site a great deal of excavation would be necessary

And the currently unbroken shoreline of beautiful trees would be disturbed. We are all concerned with the environmental issues that are involved.

The boathouse addition conceived and designed by Micheal Bird is environmentally Appropriate, the size has been reduced by many square feet, there will only need to be one exterior wall that will need footings, the design itself is aesthetically pleasing a.nd one that repeats existing roof slopes and existing materials and details. The slightly enlarged boathouse will appear to have been built at one time and with no Ostentatious elements..

The Hawkins have improved their camp in many ways since purchasing their property....new roofing, new interior floors, mechanical systems, and many native trees, shrubs and plants....their plans are long term and the additional boat slip will be a much appreciated addition to a much loved camp.

I sincerely hope the APA will approve this very reasonable request.

## Mr. Haralson-

I'm an interested landowner who has opposed the grant of a variance for construction of an added extension of a nonconforming boathouse on the increasingly congested shore of Spitfire Lake in Resource Management. I've learned that the 2021 Application was denied supported by staff's recommendation.

In connection with the Application 2022-094 I hereby request the Board take notice of my prior submissions in opposition to 2021-0249. This included an email of June 26,2022 to which is attached letter dated March 7, 1990 issued by this applicant's representative Michael Bird AIA and Mari-Beth Bird, ALSA. The Birds then opposed a variance for a subdivision near to the property under consideration largely based upon its environmental impact on the area that further boathouse and dwelling construction would have, accurately predicting this would lead to construction of 7 additional boathouses.

In the power point presentation at the hearing on the prior application the properties immediately east of the subject was show. These consists of two narrow lots bearing modest dwellings the nearest of which has only a simple dock while the one further east has none. Surely one may anticipate, as they are further developed applications for two added boathouses will be made.

While the current application is for a smaller addition to the existing non-conforming boathouse, it suffers the same adverse effects to water quality and visual impact cited in the agency's denial. Accordingly, I must continue opposing this unnecessary added burden to the environment.

This letter is in regards to Project #89-517, a 2 lot subdivision on Spitfire Lake. The applicant is George Earle. We are opposed to this subdivision for the following reasons:

- 1. The subject property falls within the Resource Management classification. According to the APA Overall Intensity Guidelines, 42.7 acres per principal building is suggested. We're suprised you are considering this application for subdivision when the subject property is only 22 acres in entirety.
- 2. The subject property is one of the few large parcels of land remaining on Spitfire and Upper St. Regis Lakes. There are four small lots directly west of Mr. Earle's property. (see enclosed map) These acreages are 4.7, 1, 3, and 3.65 respectively. The next lot is 11.5 acres. Indicated on the enclosed plan-the potential number of boathouses and principal dwellings which would be a total of seven (7) including the proposed subdivision.

Two boathouses and principal dwellings on 22 acres(the Earle property) is not congested, however, seven (7) boathouses and principal dwellings within approximately 1500' of shoreline (45 acres combining all lots) would be extremely congested.

Since the APA is concerned with the impact on the environment and surrounding lands, we feel you should consider not just the 22 acre subject property, but the entire surrounding properties and the impact as well.

3. The St. Regis Property Owner's Association conducted a survey in 1988. Almost all of the property owners were concerned with shoreline preservation. There was a consensus to limit the number of camps. Also, the Assoc. has formed a Motor Boat Safety Committee in recent years due to the increased boat traffic and hazardous boat operation. Obviously, by approving this subdivision, it will increase the boat traffic.

Our family has owned camps on these lakes since the 1920's. The changes and subdivisions that have occured in the last five years havebeen overwhelming and should be limited in the future. For the above reasons, we ask you to not approve this 2 lot subdivision.
