For action: Development of a 10MW-AC community solar generation facility to include a fixed-tilt, ground-mounted solar array with two separately fenced areas: 5MW ac on the west side of Vineyard Road and the south side of Pearl Street. No changes are proposed to an existing sand and gravel mine located on the same site to the west of the western solar site. No development is proposed north of Pearl Street.

- 1. Park Ecology Committee Report (Dr. Lizz Schuyler)
- 2. <u>For information: Presentation Adirondack Brook Trout Pond Plan</u> DEC Chief of Fisheries, Steve Hurst, will provide the Board an overview of a new draft Adirondack Brook Trout Pond Plan that will be released for public comment later this summer. The plan will serve as a conservation roadmap for the next 15 years to help preserve and protect populations of this iconic species of fish, which is an integral part of the Adirondack's natural heritage.

3. For information: Presentation — Browning and warming of Adirondack lakes limit habitat available to brook trout—Dr. Tommy Detmer, Senior Research Associate, Adirondack Fishery Research Program, Cornell University will be providing an overview on long term monitoring of Adirondack lakes that shows they are warming, becoming more teastained, and suffering oxygen depletion at the bottom. Submerged sensors reveal that both surface warming and bottom oxygen depletion are increasingly squeezing trout between inhospitable zones, and tagged trout show us that these habitat constraints limit their summertime activities. This ecological perspective complements angler data, which suggest that humans are also responding to shifting conditions in the Adirondacks.
