1. CALL TO ORDER

A quorum of board members being present in person, the meeting was called to order at approximately 9:32 AM and Chairperson Ernst welcomed the public, presenters, and staff.

2. WELCOMING REMARKS

Chairperson Ernst noted that the second phase of the rail trail is now open, and bids will be going out shortly for the launch area of the third phase. Ernst also noted that it was encouraging to see in recent press reporting that the Lake George Park Commission and Lake George Association were working together to review research and science around the long-term response of native plants after the application of ProcellaCOR. Reports indicate that their findings matched – with no traceable chemical in the water within 24 hours of application.

3. PUBLIC COMMENT

The Chair recognized Ron Konowitz, of the Adirondack Powder Skier's Association. Konowitz discussed the association's historical contributions and interests in past SLMP amendments, work the association had done in building backcountry trails, and the association's desire to be part of the Trail Stewardship Working Group. APA Counsel interjected to remind Konowitz not to comment on any pending motion before the board.

The Chair recognized Claudia Braymer, Protect the Adirondacks, who noted a preference for the length of the comment period for the SLMP amendments. APA Counsel interjected to remind Ms. Braymer that this comment should be reserved to the end of the meeting as had been noted immediately prior for Mr. Konowitz. The Chair recognized Dave Gibson, Adirondack Wild, who referenced a recent NCPR story regarding water body carrying capacity.

7. EXECUTIVE DIRECTOR'S REPORT

- Acknowledgement of the passing of Charles E. Vandrei, Jr., DEC's Historic Preservation Officer.
- Review of summer storms which lead to the approval of 11 emergency projects so far this year, the most the Agency has approved.
- In connection with previously approved ProcellaCOR applications, the agency is receiving post-application information that confirms the expected effect, anticipated dissipation of the product, measurable impacts to native vegetation.
- Staff are working on a revamped website to provide a digital resource for people to learn about the agency, submit applications, and provide a user-friendly online experience. This aligns with the Agency's contribution to the State's Government Transparency Initiative Plan, and this work has led to an increased social media presence leading to more public engagement.
- Staff updates: congratulations on the appointment of Molly Jordan to Mapping Technologist 3, and the addition of new staff members Charlotte Staats, Natural Heritage Trust State Land Planner, and Paulina Kwasniak, Receptionist.
- Thanks and acknowledgement for the work done by summer interns Lydia Harvey, Tom Shafer, Mistaya Smith and Emily Pulcini.

8.1.1. Planning Division Report

Megan Phillips, Deputy Director of State Lands and Planning, provided an update on recent Planning Division activities, highlights included:

- New staff member Charlotte Staats was welcomed as a Natural Heritage Trust state land planner to the Planning Division.
- Mistaya Smith, community design intern, completed projects in the Towns of Keene and Hague, she is tentatively slated to present her work to the October meeting of the Agency board.
- The Planning Division's GIS Intern, Emily Pulcini, will be staying on with the Agency during the fall semester as part of a course credit program at Paul Smith's College.
- Congratulations were made to Molly Jordan on her recent assignment to Mapping Technologist 3.
- State Land staff has been active in consultations with the DEC and ORDA for projects related to the UCI downhill mountain bike races at Whiteface, trail turnpiking in the Pigeon Lake Wilderness, and culvert replacements. They are also working on unit management planning for Debar Mountain Wild Forest, Pepperbox Wilderness, and John Brown Farm.
- State Land staff continue to work with the DEC on the High Peaks visitor use management framework project and the Trail Stewardship Working Group.
- The Local Government Services team processed 81 variance referrals from Agency-approved local land use programs (ALLUPs) to date in calendar year 2024. They have also been meeting with town supervisors, enforcement officers and zoning administrators to assist with implementation of ALLUPs and ensure that they have the training they need.
- Robyn Burgess, from the Local Government team will be presenting on zoning in the Adirondack Park at the NY Planning Federation Conference in Lake Placid later this month.

8.1.2. Cranberry Lake Campground Unit Management Plan Amendment (Oliver Miller, DEC, Josh Houghton, DEC, and Kevin Prickett, APA)

Oliver Miller, Department of Environmental Conservation, and Kevin Prickett, Adirondack Park Agency, presented their recommendation, including public comments, on the proposed amendment to the 2016 Cranberry Lake Campground UMP and its conformance to the State Land Master Plan.

On motion of Zoë Smith, seconded by Joe Zalewski, the committee unanimously resolved to recommend to the full board for approval a resolution finding the 2024 UMP Amendment for the Cranberry Lake Public Campground in conformance with the general guidelines and criteria of the Adirondack Park State Land Master Plan.

Dan Plumley of Keene expressed concern regarding the visitor use management plan in the SLMP would control numbers, he would like to see the Agency look again at a permitting process for recreational access to certain state lands.

RESOLUTION OF THE ADIRONDACK PARK AGENCY WITH RESPECT TO THE 2024 UNIT MANAGEMENT PLAN AMENDMENT FOR THE CRANBERRY LAKE PUBLIC CAMPGROUND INTENSIVE USE AREA

September 12th, 2024

WHEREAS, Section 816 of the Adirondack Park Agency Act (APA Act) directs the Department of Environmental Conservation (DEC) to develop, in consultation with the Adirondack Park Agency (Agency), individual management plans for units of land classified in the Adirondack Park State Land Master Plan (APSLMP) and requires such management plans to conform to the guidelines and criteria of the APSLMP; and

WHEREAS, in addition to such guidelines and criteria, the APSLMP prescribes the contents of unit management plans (UMPs) and provides that the Agency will determine whether a proposed individual UMP complies with such guidelines and criteria; and

WHEREAS, in March 1993, the DEC adopted the Cranberry Lake Public Campground Final UMP; and

WHEREAS, in September 2016, the DEC adopted the Cranberry Lake Public Campground UMP superseding the Cranberry Lake Public Campground Final UMP dated March 1993; and

WHEREAS, the APSLMP identifies Cranberry Lake Public Campground as an existing intensive use area campground; and

WHEREAS, the proposed project conforms to the basic guidelines for Intensive Use Areas and will avoid material alteration of wetlands, minimize extensive topographic alterations, limit vegetative clearing, and preserve the scenic, natural and open space resources of the intensive use area; and

WHEREAS, the plan proposes the use of natural materials to the fullest extent possible so as to blend with the relatively wild and undeveloped character of the Adirondack Park; and

WHEREAS, on May 16th, 2024, DEC presented the Draft 2024 UMP Amendment to the Agency and the Agency authorized a joint public comment period on the Draft 2024 UMP Amendment from May 17th, 2024, through June 17th, 2024; and

WHEREAS, the DEC and Agency received three written comments during its public comment period; and

WHEREAS, the 2024 UMP Amendment proposes to construct a rustic playground; and

WHEREAS, the 2024 UMP Amendment proposes activities consistent with those contemplated in the amended 1990 Generic UMP/Environmental Impact Statement; and

WHEREAS, on September 12th, 2024, the DEC presented the 2024 UMP Amendment to the Agency and Agency staff made a presented the recommendation that the 2024 UMP Amendment conforms with the guidelines and criteria of the APSLMP; and

WHEREAS, in accordance with Section 7 of New York State's Climate Leadership and Community Protection Act (CLCPA), the Agency has considered climate change and the state's climate goals and finds that the Proposed Final 2024 Unit Management Plan Amendment (2024 UMP Amendment) is not inconsistent with, and will not interfere with, the attainment of the state's greenhouse gas emissions limits; and

WHEREAS, the Agency has considered the 2024 UMP Amendment, the May 16th, 2024, and September 12th, 2024 staff presentations, comments received by the public, and the deliberations of Agency Board Members and designees at the Agency's September 12th, 2024 meeting.

NOW, THEREFORE, BE IT RESOLVED that pursuant to Section 816 of the Adirondack Park Agency Act, the Agency finds that the Proposed Final Unit Management Plan Amendment for the Cranberry Lake Public Campground Intensive Use Area, dated August 2024, conforms with the guidelines and criteria of the APSLMP; and

BE IT FINALLY RESOLVED that the Agency authorizes its Executive Director to advise the Commissioner of the Department of Environmental Conservation of the Agency's determination in this matter.

RESOLUTION

OF THE ADIRONDACK PARK AGENCY WITH RESPECT TO THE PROPOSAL TO AMEND THE ADIRONDACK PARK STATE LAND MASTER PLAN

September 12, 2024

WHEREAS, Section 816 of the Adirondack Park Agency Act (Executive Law, Article 27) provides that the Adirondack Park State Land Master Plan (APSLMP) should be reviewed periodically and may be amended and that any amendments shall be prepared by the Adirondack Park Agency (APA or Agency) in consultation with the Department of Environmental Conservation (Department or DEC) and submitted to the Governor for her approval after public hearings have been held on the amendments; and

WHEREAS, the APSLMP provides that amendments shall be effectuated in the same manner as its original adoption and should be subject to public hearings within and without the Park; and

WHEREAS, the Agency adopted a Final Programmatic Environmental Impact Statement (FPEIS) entitled, "Guidelines for Amending the Adirondack Park State Land Master Plan," dated February 28, 1979, that sets forth the factors to be considered for the classification of recent acquisitions and the alteration of introductory guidelines, guidelines for management and use, area descriptions, definitions of existing classifications, and facility definitions.

WHEREAS, the APSLMP provides criteria for classifying state lands within the Adirondack Park according to their characteristics and capacity to withstand use; and

WHEREAS, the Department has acquired approximately 585 acres of land in the Town of Jay in Essex County; and

WHEREAS, the Memorandum of Understanding Between the Agency and the Department Concerning Implementation of the State Land Master Plan for the Adirondack Park, (MOU) provides procedures for consultation and consideration of proposed changes to the APSLMP; and

WHEREAS, the Agency consulted with the Department as required by the MOU and has prepared recommendations for amendments to the APSLMP which constitute a periodic review of the entire plan; and

WHEREAS, Agency staff presented a summary of the proposed amendments package to the Agency Board at its September 12, 2024 meeting and defined the action under the State Environmental Quality Review Act (SEQRA); and

WHEREAS, Agency staff determined the action to be a Type I action under APA Rules and Regulations (9 NYCRR 586.5(a)(6)(iv));

NOW, THEREFORE BE IT RESOLVED, Agency staff are authorized to initiate a coordinated review pursuant to the SEQRA (6 NYCRR Part 617), Agency regulations (9 NYCRR Part 586), and the FPEIS, and to inform potential involved agencies to the action and seek lead agency status with respect to the proposed amendments package; and

BE IT FURTHER RESOLVED, Agency staff are authorized to conduct at least two public hearings and hold a sixty-day public comment period on the proposed amendments package; and

BE IT FURTHER RESOLVED, Agency staff will summarize written and verbal comments and present these and a proposed final amendments package to the Board at a future meeting.
