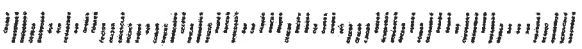

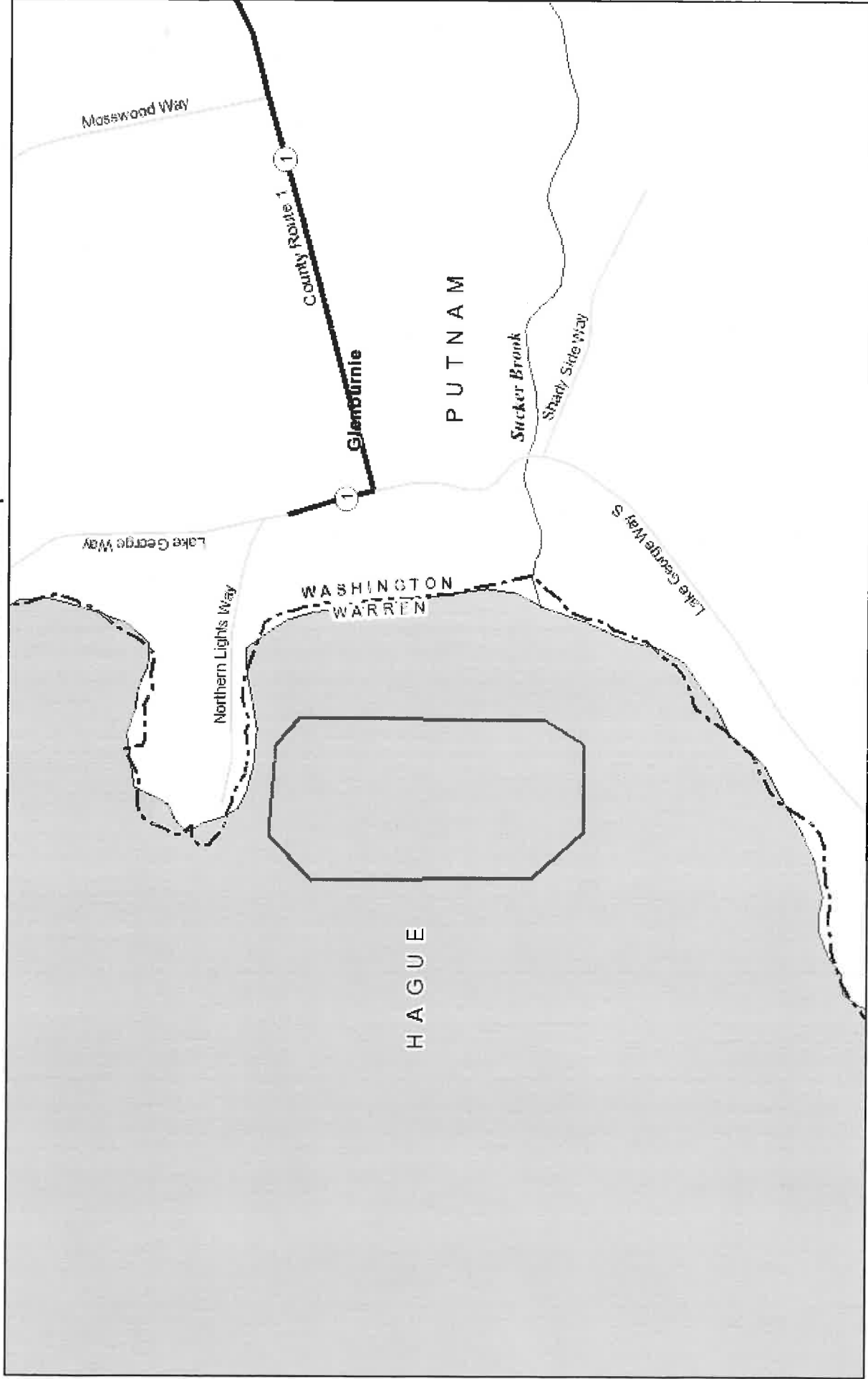

P2022-0004 Location Map



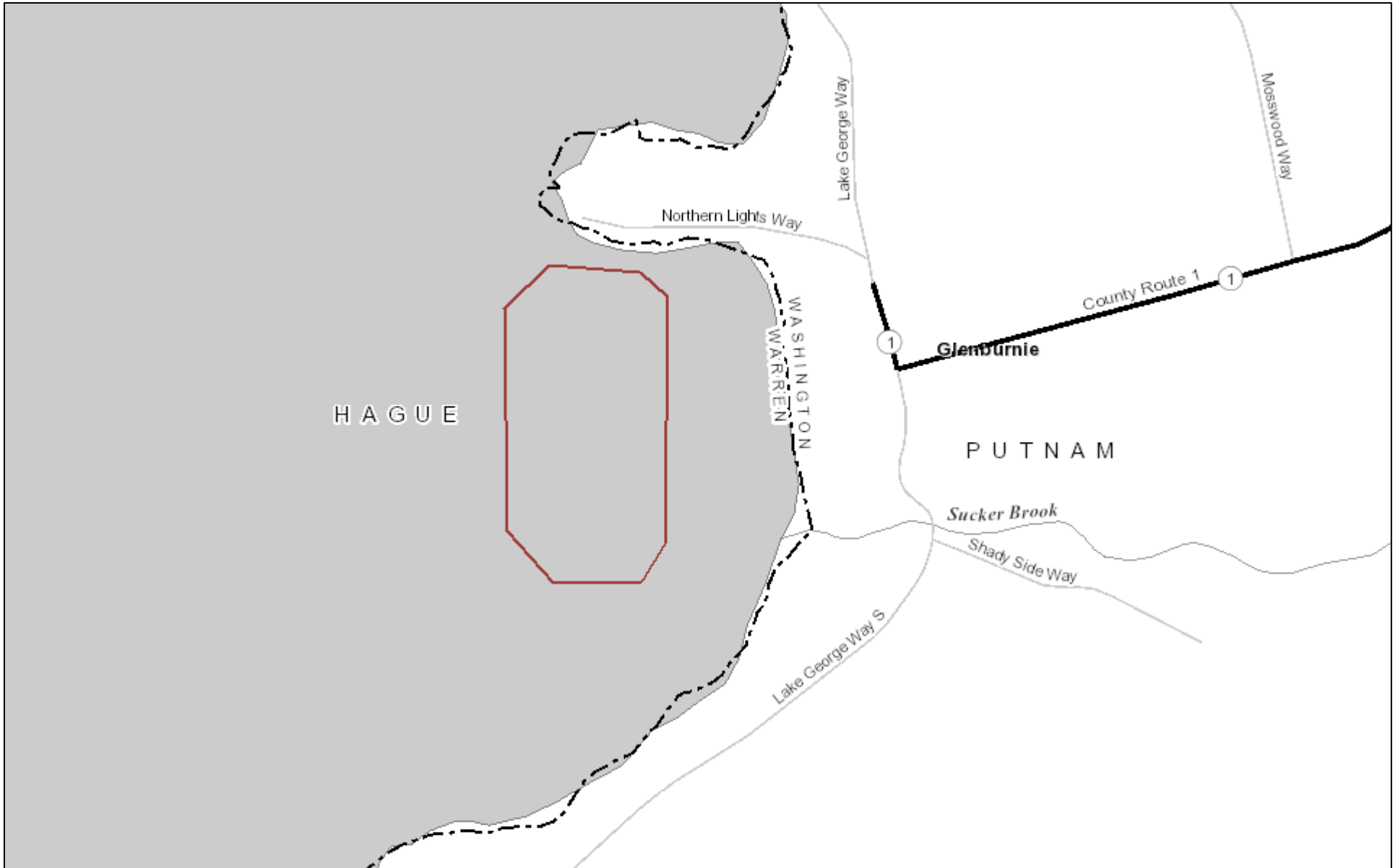

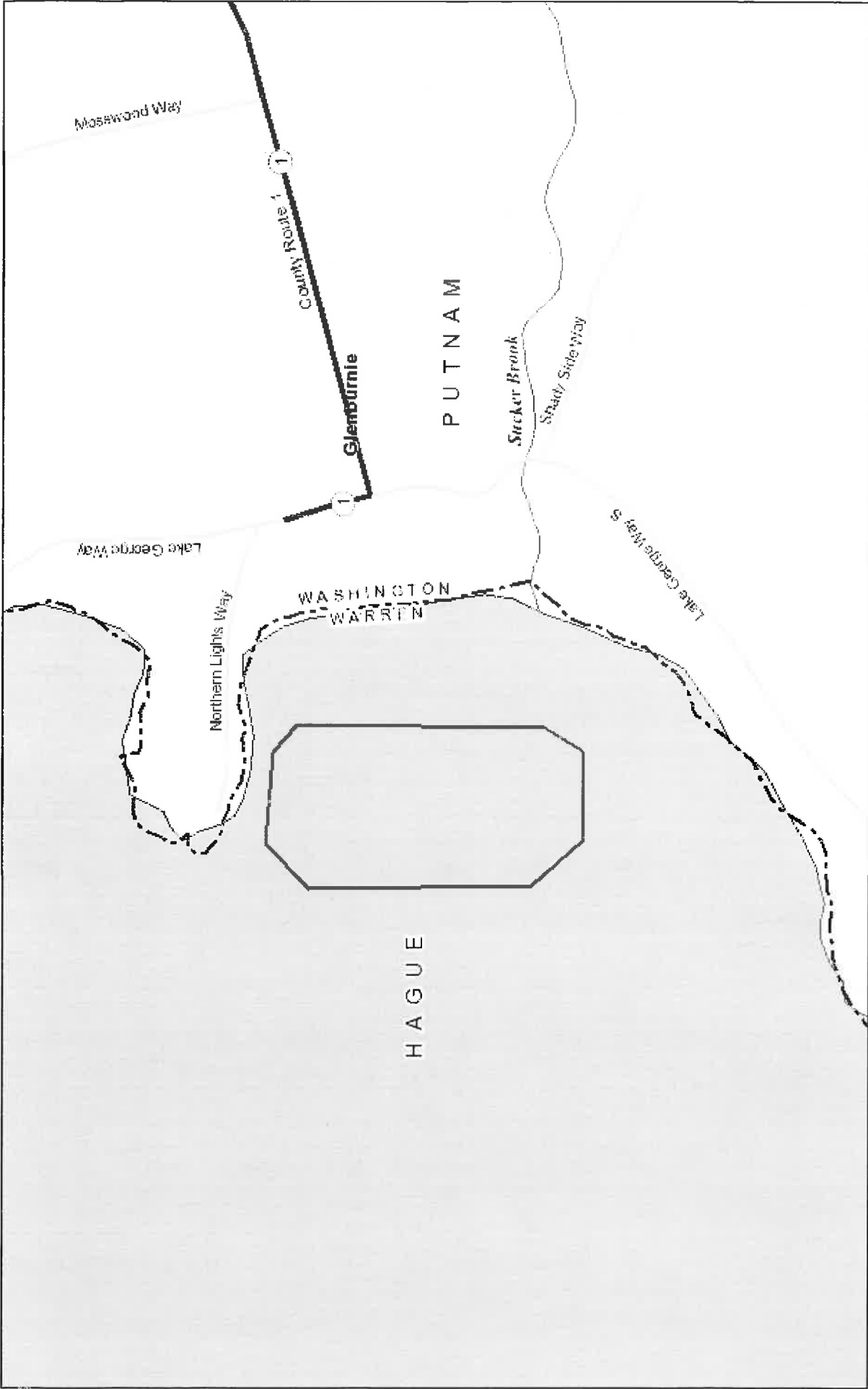
