Emergency Certification

The proposal described below constitutes an emergency project pursuant to § 572.15(c) of the Adirondack Park Agency Rules and Regulations and is being undertaken to protect life and/or property. Accordingly, no permit or further review of the proposal is required from the Adirondack Park Agency. This Emergency Certificate is based on and made only for the project described in the documents submitted in the June 23, 2025 correspondence from Jason Burke (Barton & Loguidice) on behalf of the Town of Hopkinton to the Agency.

No otherwise jurisdictional activity shall occur on the project site without prior Agency approval beyond the emergency project described herein. Once there is no longer an immediate threat to life or property, the Applicant shall seek authorization from the Agency for any additional planned repairs, remediation or recovery from the emergency.

Project Site

Town/Village: Hopkinton

County: St. Lawrence

Road and/or Water Body: Lake Ozonia Road/ Cold Hill Brook

Land Use Area/State Land Classification: Resource Management and Rural Use

Emergency Project Description

On August 9, 2024, heavy rain and severe flooding created hazardous conditions in New York State posing an imminent danger to public transportation, utility service, public health, and public safety systems. On August 9, 2024, Governor Kathy Hochul issued Executive Order 38 declaring a State Disaster Emergency in St. Lawrence County. The St. Lawrence County Board of Legislators also issued a State of Emergency Declaration on August 9, 2024. The proposed project involves replacement of an existing failed concrete slab superstructure bridge spanning 15 feet with a triple

barrel 60-inch-diameter by 40-foot-long Smooth Interior Corrugated Polyethylene Pipe (SICPP) over Cold Hill Brook to reopen Lake Ozonia Road.


General Notice
