Mr. Austin reported the Board met in Executive Session and no action was taken.

#### **1) Committee Reports**

##### **a) Local Government Services**

Mr. Austin reported on the presentation by Robyn Burgess on an overview of Local Land Use Controls and Regulation of Solar in the Adirondack Park.

##### **b) Park Policy and Planning Committee**

Mr. Ernst reported on the presentation by Matt Kendall on a Parkwide Look at Existing and Proposed Solar Projects/ GIS Mapping.

##### **c) Regulatory Programs Committee**

On motion of Mr. Austin, seconded by Mr. Hall, the Agency unanimously approved P2021-0033,789 Tarbell Hill, LLC involving the development of a 5MW solar power

generating facility on 25 acres of leased land within two separate fenced areas totaling 18 acres. Access is proposed from Tarbell Hill Road and Dugway Road, Town of Moriah, Essex County. Ms. Regan reported on data regarding the bat population. Mr. Lussi commented on the land clearing and visual impacts of solar projects.

d) State Land Committee

On motion of Mr. Ernst, seconded by Mr. Hall, the Agency unanimously authorized the Fish Creek Campground UMP Amendment to proceed to public comment for SLMP conformance. Ms. Smith requested additional information be added regarding the objectives for resource protection and visitor use. Mr. Lussi said the UMP should address access to the rail trail.

The Administration, Economic Affairs, Enforcement, Legal Affairs, Park Ecology, Public Awareness committees did not meet this month. Ms. Martino congratulated Ms. Darrah on her promotion to EPS 2 in the JIF office and thanked Ms. Caldwell for working through the hiring process.

Mr. Ernst said he believed it was a great meeting with a lot of planning work.

Mr. Cooper thanked the legal staff and congratulated Ms. Darrah on her promotion.

Ms. Martino commented on the book *A Wild Idea* by Brad Edmondson and said the ADK Experience would host a virtual symposium on June 22 to highlight fifty-years of the Adirondack Park Agency. She said the Agency will plan a fifty-year anniversary celebration in 2023, following on when the thirtieth was celebrated in 2003 and the fortieth in 2013. She thanked staff for their work.

Mr. Austin told members if they have concerns, comments, or questions, staff are always available to discuss project details. He said he believes the VUM is a great tool going forward.
