Regulatory Programs Report (Robert Lore)

Mr. Lore began his report by highlighted the divisions workload from April to June of this year and how it compares it to the same reporting period from last year. Although the number permits issued and year-to-date numbers for 2020 and 2021 are relatively the same, Mr. Lore stated that the number of pre-applications doubled compared to last year. While they are not formal applications at that stage, they do still entail a lot of staff work. Mr. Lore also highlighted some of the current projects the division is currently working on, including the pre-application for Barton Mines in the towns of Johnsburg and Indian Lake, and the application for a mineral extraction quarry in the Town of Forestport, as well as a solar project in Ticonderoga.
