Executive Director Barbara Rice presented her report, highlights of which included:

- Acknowledging the 24<sup>th</sup> anniversary of 9/11, honoring and remembering those directly impacted by those events. New York State continues to offer assistance to those who were at the World Trade Center, in parts of Brooklyn or who took part in the rescue, recovery and cleanup efforts there, at the Pentagon or in Shanksville.
- Thanking Jerry Delaney and the Local Government Review Board (LGRB) for organizing a productive discussion at a recent LGRB meeting which included representatives from DANC and LGLCRPC regarding the challenges of providing cellular and emergency services in the Park.
- Welcoming new staff member and Excelsior Fellow Amara Mitchell, who will
  be assessing the Agency's existing statutes, regulations and policies to
  determine how they may be modernized to address the challenges and
  opportunities facing the Adirondack region today.

# (1) Planning Division Report

Megan Phillips, Deputy Director of Planning, presented the Planning Division report, highlights of which included:

- Welcoming Amara Mitchell, the APA's Excelsior Fellow who started this week.
- State Land staff have received 29 consultations to date for projects that the DEC or ORDA are looking to undertake on State Lands.
- State Land staff continue to work with DEC on trail stewardship guidelines and parameters.
- Staff will be participating in the Adirondack Park and Catskill Parks Forest Preserve Summit.
- The GIS team is in the process of rebuilding the Agency's internal spatial analysis and decision support tool in a new ESRI software for use on a new GIS server.
- Local Government Services have responded to 103 variance referrals so far this year. They are also preparing to conduct a training for Essex County planning and zoning members alongside Department of State staff.

- Round eight of the DEC's smart growth grant program is still open for another three weeks with a goal of supporting projects that build on comprehensive planning and economic development activities with a priority on affordable housing.
- Local Government Service and State Land teams will be participating on a steering committee lead by Lake Champlain Lake George Regional Planning Board to inform Hamilton County's efforts to connect outdoor recreational assets to main streets to foster economic development in rural communities in a program funded by the US EPA.
- (2) Proposed Final Adirondack State Land Master Plan Amendments

Agency staff summarized changes from the draft to the proposed final 2024-2025 Adirondack Park State Land Master Plan amendments package and shared a staff recommendation and resolution for board action.

On motion of Joe Zalewski, seconded by Zoë Smith, the State Land Committee unanimously recommended the adoption of the resolution as presented to the full board.

# (3) DEC Adirondack Rail Trail

Rob Daley (Department of Environmental Conservation) provided an informational presentation regarding the background of the Adirondack Rail Trail, and an update on Phase 3 of the project and plans for future improvements.

- (1) Regulatory Programs Report John Burth, APA, presented the Regulatory Programs Report, highlighting:
  - As of the end of August, 2025, the Regulatory Programs Division has received 252 permit applications, down from 310 received this time last year. They have also received 99 pre-applications which is slightly elevated from the 95 received by this time last year.
  - They have issued 205 permits, up from 190 issued at this time in 2024. 51
    major projects have been completed compared to 56 at this time last year,
    and 6 emergency authorizations have been granted down from 14 last year.
  - The process for submitting and reviewing subdivision projects was presented and two projects currently in that process were highlighted.
  - A lookback on the solar permits used by the agency between 2020 and 2024 ranging in size from 5MW to 20MW.
- (2) P2025-0015 Catalyze Solar, Town of Ausable Clinton County

Devan Korn, APA, provided an overview of the proposed project for a 5.0 MW solar generation facility in the Town of Ausable.

On motion of Dan Wilt, seconded by Matt Tebo, the Regulatory Committee recommended the approval of the application as presented with recommended conditions to the full board in a vote of three to one.

Committee adjourned at approximately 1:52 PM.

The committee received a Planning Division Report from Megan Phillips and a summary of changes to the final draft of the 2024-2025 Adirondack Park State Land Master Plan and proposed resolution. On motion of Ken Lynch and seconded by Art Lussi the board voted to approve the resolution by a vote of 9 in favor and one abstention.

The committee also heard an informational presentation from the Department of Environmental Conservation which provided the background on, and update to Phase 3 of and plans for future improvements to the Adirondack Rail Trail.

# 10.3 Public Awareness and Communication (Mark Hall)

The committee received a communications report and informational presentation regarding the status of the Adirondack Park Agency headquarters project, including conceptual proposals for relocation to the Village of Saranac Lake.

# 10.4 Regulatory Programs (Dan Wilt)

The committee reviewed a proposed project (P2025-0015) from Catalyze Solar for a 5.0 MW solar generation facility in the Town of Ausable, Clinton County. On motion of Dan Wilt, and seconded by Ken Lynch, the board voted to approve the permit with conditions by a vote of nine in favor and one opposed.

#### 11. INTERIM REPORTS

The Administration, Economic Affairs, Enforcement, Legal, Local Government Services, and Park Ecology committees did not meet this month.

G. Delaney noted that while ADA compliance was not addressed in the Adirondack Park State Land Master Plan amendment package, we heard reports from the DEC and ARTA about the accessibility of the Adirondack Rail Trail. Delaney added that Local Government would like to see resources put in place to get Unit Management Plans completed.
