I am a huge supporter of renewables. My associates and bachelors degrees are both within renewables. I have spent my working life working outdoors in gardens, cemeteries, electrical and energy efficiency work to solar foreman and design and engineering for PV, energy storage, and EV chargers. From residential scale up to now doing engineering for utility scale renewables. Similar scale and projects as this one for a New England based company Norwich Solar based in VT. Renewable deployment is vital to our energy future. Proper system siting, necessary safety training and general public awareness are all keys to successful deployment. The general public tends to lean on the NIMBYism mindset. Transparency is vital to allowing the public to feel involved. The other piece in my experience is money. Money talks. The general public does not fully understand the participation of ancillary services, load shedding or time of use. Direct payments or energy production guarantees to local communities. Specifically offering to provide pv arrays to municipalities and schools can help communities see the direct benefit to renewables. Energy storage is a difficult topic due to misinformation and common acceptance of "it's not safe". Local training for first responders, requiring an on site or on call site technician or manager can help mitigate response time concerns. Consistent and often 3rd party reviews by multiple independent engineers can help fill in the gap of understanding between public knowledge and industry practices and safeguards particularly if a government authority lacks the experience in thoroughly reviewing project details and would highly suggest this. It is common practice to see it within the engineering and design phases as well as the construction and commissioning phases. It is a funny thought that the same people who want to save a protected area such as the adk park, also quickly dismiss the use of renewables. There will always be opposition but I find it of utmost importance to stay the course on renewables by making consistent conscious decisions on safety, public education, community impact and site design/analysis while following construction best practices.

I am writing as a concerned resident regarding the proposed battery energy storage facility being considered within our town boundaries and within the Adirondack Park. I strongly urge the Board to carefully consider the long-term environmental, safety, and economic impacts before allowing this development to proceed.

The Adirondack Park is protected under the New York State Constitution's "Forever Wild" clause for a reason. This designation is intended to preserve the park's natural resources, air quality, wildlife, and rural character for future generations. Industrial-scale energy infrastructure, particularly battery storage facilities, appears inconsistent with both the spirit and intent of these protections.

Lithium-ion battery storage facilities present well-documented fire risks. Once ignited, these fires are extremely difficult to extinguish, can burn for extended periods, and release toxic gases and particulates into the air. In a park environment known for clean air, sensitive ecosystems, and limited emergency response infrastructure, the consequences of a single incident could be severe. Smoke and airborne contaminants from battery fires pose risks not only to wildlife but also to residents, visitors, and first responders.

In addition to safety concerns, the presence of a large-scale battery facility may negatively impact nearby property values. Numerous homeowners reasonably fear reduced desirability due to perceived fire risk, industrialization of a rural area, noise, visual impacts, and potential environmental contamination. Property owners should not bear a financial burden as a result of development that primarily benefits outside commercial interests.

I fully support responsible renewable energy solutions, but they must be appropriately sited. The Adirondack Park is not an industrial zone. There are alternative locations outside protected areas where such facilities could be developed without compromising one of New York's most treasured natural resources.

I respectfully ask the Planning Board to prioritize environmental stewardship, public safety, and community character by rejecting or relocating this proposal. Once the "Forever Wild" protections are compromised, the damage cannot easily be undone.

Thank you for your time and for considering the long-term impact of this decision on our community and the Adirondack Park.

To Whom It May Concern,

I respectfully submit the following comments regarding the proposal by Carson Power to construct a lithium battery energy storage facility within the Adirondack Park near the Great Sacandaga Lake in the Town of Northampton.

I am deeply concerned about the safety risks associated with a lithium-ion battery storage facility. These systems are known to pose risks of thermal runaway and fires that are extremely difficult to control or extinguish. Such fires may release toxic gases and can reignite after initial suppression, presenting a serious ongoing hazard to emergency responders and nearby residents.

The proposed location near the Great Sacandaga Lake and other surrounding water resources is particularly troubling. Any fire, chemical release, or contaminated runoff could threaten surface water, groundwater, aquatic ecosystems, and drinking water quality. The Adirondack Park is an environmentally protected area of statewide importance, and projects that introduce potential contamination risks must be evaluated with exceptional caution.

I am also concerned about the impact this facility may have on local residents. This community is valued for its rural character, summer tourism and recreation, natural beauty, and quiet environment. The proposed area is also in close proximity to the Great Sacandaga Reservoir and wetland areas. If there happened to be a fire I am concerned about toxicity that could be released by the facility along with fire fighting chemicals.

For these reasons, I urge the reviewing agencies and decision-makers to conduct a thorough and transparent review of this proposal, including independent safety analyses and realistic emergency response planning. The protection of public safety, local residents, and the unique environmental resources of the Adirondack Park must be prioritized.

I have concerns about lithium ion battery units and do not want to see one constructed in the Town of Northampton.
My concerns are as follows:

1. Fire/explosion hazard. Resulting in increased cost, risk and training requirements for local volunteer fire departments that are already hurting for volunteers. Increased cost to tax payers.
2. Battery lifespan. General lifespan is significantly less than other power storage options such as pumped hydropower storage. Battery lifespan also depends on charging/draw rates, temperatures at the time of charge (adherence to Smart Battery Management Systems).
3. Environmental hazard. Use of chemical storage.
4. Battery capacity and efficiency significantly decreases during cold temperatures.
5. True battery storage potential. Battery lifespan is improved if batteries are not charged to 100%. To maximize lifespan you will sacrifice actual battery storage capacity.

I have significant concerns with this project. There are two other locations with this type of storage site that have caught fire and one recently burned for many days, polluting both air and potentially water. Many, very-nearby residents including myself have shallow wells and the threat of water contamination is very real even with the designed "safeguards" in place.

There is not nearly enough justification for the need of this storage. The actual problem is **utilization**. Who are the ACTUAL beneficiaries of this project? Though energy costs are up, there is no quantitative proposal for savings to average grid-users. There is NO clear benefit to our local community. RE: Carson Power Lithium Battery Storage Facility Proposal for Town of Northampton, NY

I am the Town of Northampton Supervisor and a volunteer fireman with the Great Sacandaga Lake Fire District in Northville.

I have several concerns, both personal and as a public official, over the proposed lithium battery storage facility in the Town of Northampton.

Since the date of the initial Town of Northampton Planning Board meeting on the project, it has come to light that there have been recent fires of a large magnitude in facilities similar to this project in communities not unlike Northampton. I specifically cite the information regarding the Warwick NY fire on December 19, 2025. It is clear that the fires in Warwick were caused by water infiltrating the units housing the batteries.

The location of the Northampton proposed facility is along a major highway in the Adirondack Park. I have concerns that a fire at the facility will cause a disruption to traffic due to the close proximity of the highway. That location is also a wetland which cause impact in case there was any ground water contamination that could affect adjacent property owners who have wells.

The proposed location is surrounded by dense vegetation and I have concerns that a fire at the storage facility fanned by winds could ignite the area quickly.

As a fireman, my concerns are great. We have an aging volunteer department with low recruitment. Fire departments in neighboring communities face the same problem. I understand that fires at facilities like this cannot be extinguished with water and must burn out, requiring the need for constant monitoring. Our department would have difficulty handling the burden and still have to answer other calls to protect the public.

The potential for air quality issue arising from a fire at a facility of this time are a great concern. Our area has experienced two summers of very poor air quality due to the Canadian wildfires that burned for months. We have a large aging population and a significant number of residents with respiratory condition that would be greatly impacted.

The Adirondack Park is a unique environmental resource for all to enjoy. To have a facility of this magnitude located in the Park, so close to lakes and rivers and other habitats that the APA strives to protect contradicts the purpose of the Park.

The Planning Board spent considerable time discussing whether or not to advance the project. Had they the information regard the Warwick, NY fires, they most likely would not have advanced the project.

I have reviewed the Decommissioning Plan and nowhere is made mention of who is responsible for cleaning up the facility from damages due a fire.

Upon further review of the documents you submitted, I reviewed the Groundwater Safety for Battery Energy Storage Systems and there is erroneous information regarding the municipal water in the area. In Section #1, paragraph three, it states " For the Village of Northville, the Water Department has confirmed that municipal drinking water is sourced from protected subsurface aquifers, not from surface water. Therefore, even in a hypothetical worst-case scenario, surface-level runoff from a BESS incident would not interact with or affect the municipal groundwater supply. More details on how the water system is project can be found in Appendix 2, which is an excerpt from the Villages water department website." This is not factual information. The Village of Northville water system does not service residents along the Route 30 corridor. The area, north and southwest of the proposed site, is serviced by the Sacandaga Park Water District which is an entirely different water source. The information in the quote you provided comes from the Water Quality report for the Village of Northville and again, has no bearing on the site proposed. I would think that Carson Power would provide accurate information in their application.

I am writing to express my strong opposition to permitting large-scale lithium-ion battery energy storage systems (BESS) within the Adirondack Park. While I recognize the importance of renewable energy and grid modernization, the placement of industrial-scale lithium-ion storage facilities inside or adjacent to protected Park lands poses unacceptable risks to public safety, ecological integrity, and the long-term character of the region.

1. Fire, Explosion, and Toxic Release Risks Lithium-ion battery systems carry well-documented hazards, including thermal runaway, chemical fires, and the release of toxic gases. These incidents are notoriously difficult to extinguish and often require specialized firefighting resources that rural Adirondack communities simply do not have. A single malfunction can result in:

- Multi-day fires that release hazardous fumes
- Contamination of soil and waterways from fire-suppression runoff
- Evacuation zones extending far beyond the facility footprint

Given the Park's remote terrain, limited emergency response capacity, and the proximity of many proposed sites to homes, schools, and natural water systems, these risks are amplified rather than mitigated.

2. Incompatibility With the Adirondack Park's Mission The Adirondack Park was established to preserve wilderness, protect natural resources, and maintain the rural character of its communities. Industrial battery storage facilities—often involving acres of containers, transformers, fencing, and security infrastructure—are fundamentally inconsistent with:

- The Park's scenic and ecological values

- The APA's mandate to avoid undue adverse environmental impacts
- The expectations of residents and visitors who rely on the Park's unique landscape

Allowing this type of industrial development sets a precedent that could erode the Park's protections over time.

3. Insufficient Long-Term Waste and Decommissioning Plans

Lithium-ion batteries have a limited lifespan and

contain hazardous materials that require specialized disposal or recycling. Many proposals lack:

- Clear end-of-life management plans
- Financial assurances for decommissioning
- Guarantees that waste will not burden local communities or the Park's environment

Without strict, enforceable requirements, the Park risks becoming a long-term storage site for industrial waste.

4. Environmental and Wildlife Impacts

Battery storage facilities require land clearing, grading, and the installation of impermeable surfaces. These changes can disrupt wildlife corridors, increase stormwater runoff, and degrade sensitive habitats. The Adirondack Park's ecosystems are already vulnerable to climate stressors; adding industrial infrastructure only compounds these pressures.

5. Better Alternatives Exist

Energy storage is important, but the Adirondack Park is not the appropriate location for high-risk, industrial-scale

lithium-ion facilities. Safer alternatives—such as distributed storage outside the Park, non-lithium technologies, or

grid-level solutions located in already-industrialized zones—should be prioritized.

Conclusion

The Adirondack Park is a globally unique landscape that demands the highest level of protection. The risks

associated with lithium-ion battery storage facilities—combined with their industrial footprint and long-term

environmental implications—make them incompatible with the Park's mission and the APA's responsibility to safeguard this region for future generations.

I urge the Agency to reject applications for lithium-ion battery storage facilities within the Adirondack Park and to pursue energy solutions that do not compromise public safety, ecological health, or the Park's defining character. Thank you for considering this comment.

NYS Rt30 is the gateway to the Adirondacks. To promote tourism – the primary economic base of the community - Fulton County recently started construction of a (multimillion \$) Welcome Center nearby along RT30 in Northville. To further promote tourism, the Town of Northhampton has made a concerted effort over the past few years to clean up the section of Rt30 North of the RT152 intersection towards Northville. This is the area where the proposed BESS will be located! There is no way such a facility can be screened – as the visuals in the application make clear. Lots of tall electrical posts and overhead wires cannot be screened and the proposed vegetation screening of the battery units is puny. This will be a new eyesore. This area is in the Adirondack Park and a reasonably pristine appearance of the surroundings should be a priority. I put my money where my mouth is when I built a 15-unit cottage-like residential community in Sacandaga Park in that same area along RT30; that project includes a 100ft wide no-cut vegetation screening zone over a distance of 800ft on prime real estate.

For the Northville/Northhampton community there is no upside to having this BESS facility – there is only downside, risks and burdens – fire hazards, toxic emissions, runoff into nearby wetlands, emergency response expenses, reduced property values, health concerns of residents and a negative tourism perception. This BESS project does nothing for improving electricity pricing or grid stability for our community – those benefits are regional. Having this backup is meaningless when loss of power around here is mostly due to falling trees and ice and there is no negotiated microgrid option. Environmental benefits like cleaner air are nonexistent – we already have clean air. BESS business does not do anything for attracting tourists, employs nobody local except perhaps for snow removal and 1 part-time maintenance job. BESS unit presence discourages attracting more desirable business to this mixed-use zoning part of RT30 – another negative. Tourists perceive BESS units as industrial and risky – not as part of the clean green energy movement. Our aging volunteer fire department is not in a position and does not have the resources to effectively manage and contain large lithium battery fires and explosions.

In summary, the benefits of this type of BESS technology are non-existent for our community (and marginal in general). Local community risks and burdens are high and it will have a negative impact on the dominant economic driver, that is tourism.

I am writing to express my strong opposition to permitting large-scale lithium-ion battery energy storage systems (BESS) within the Adirondack Park. While I recognize the importance of renewable energy and grid modernization, the placement of industrial-scale lithium-ion storage facilities inside or adjacent to protected Park lands poses unacceptable risks to public safety, ecological integrity, and the long-term character of the region.

1. Fire, Explosion, and Toxic Release Risks

Lithium-ion battery systems carry well-documented hazards, including thermal runaway, chemical fires, and the release of toxic gases. These incidents are notoriously difficult to extinguish and often require specialized firefighting resources that rural Adirondack communities simply do not have. A single malfunction can result in:

- Multi-day fires that release hazardous fumes
- Contamination of soil and waterways from fire-suppression runoff
- Evacuation zones extending far beyond the facility footprint

Given the Park's remote terrain, limited emergency response capacity, and the proximity of many proposed sites to homes, schools, and natural water systems, these risks are amplified rather than mitigated.

2. Incompatibility With the Adirondack Park's Mission

The Adirondack Park was established to preserve wilderness, protect natural resources, and maintain the rural character of its communities. Industrial battery storage facilities—often involving acres of containers, transformers, fencing, and security infrastructure—are fundamentally inconsistent with:

- The Park's scenic and ecological values
- The APA's mandate to avoid undue adverse environmental impacts
- The expectations of residents and visitors who rely on the Park's unique landscape

Allowing this type of industrial development sets a precedent that could erode the Park's protections over time.

3. Insufficient Long-Term Waste and Decommissioning Plans

Lithium-ion batteries have a limited lifespan and contain hazardous materials that require specialized disposal or recycling. Many proposals lack:

- Clear end-of-life management plans
- Financial assurances for decommissioning
- Guarantees that waste will not burden local communities or the Park's environment

Without strict, enforceable requirements, the Park risks becoming a long-term storage site for industrial waste.

4. Environmental and Wildlife Impacts

Battery storage facilities require land clearing, grading, and the installation of impermeable surfaces. These changes can disrupt wildlife corridors, increase stormwater runoff, and degrade sensitive habitats. The Adirondack Park's ecosystems are already vulnerable to climate stressors; adding industrial infrastructure only compounds these pressures.

5. Better Alternatives Exist

Energy storage is important, but the Adirondack Park is not the appropriate location for high-risk, industrial-scale lithium-ion facilities. Safer alternatives—such as distributed storage outside the Park, non-lithium technologies, or grid-level solutions located in already-industrialized zones—should be prioritized.

The Adirondack Park is a globally unique landscape that demands the highest level of protection. The risks associated with lithium-ion battery storage facilities—combined with their industrial footprint and long-term

environmental implications—make them incompatible with the Park’s mission and the APA’s responsibility to safeguard this region for future generations.

I urge the Agency to reject applications for lithium-ion battery storage facilities within the Adirondack Park and to pursue energy solutions that do not compromise public safety, ecological health, or the Park’s defining character.

This is in regards to the Carson Power Lithium Ion Battery Project in Northampton. Project #2025-0238

Comments:

As a Northville homeowner and Adirondack lover, I am opposed to the Carson Power Lithium Ion Battery proposal.

There seem to be too many risks and unknowns for this project to proceed.

What is the expected life cycle of a facility like this? How long will it provide value and what happens when it stops?

Who will implement the decommissioning?

It will cost 4 million to decommission, who will pay for that?

What is the real estimated energy value to an average home owner in the area, per year? From the info provided and my own research it appears to be no value.

This will likely reduce the property value and overall "curb appeal" of Northville. Northville has been a nucleus of nature and clean water and trees, a welcoming gateway to the Adirondacks. A buzzing large block of battery building, will give potential house buyers or new business seekers the feeling that this is a place of ugliness and greed and potentially harmful tech. The people of Northville like to keep their ugliness hidden and secret. Most Northville residents aim to use greed, power, and ugliness as their human selves, to attack and ostracize people, not use blocky tech to do it. The ugliness and greed of a lithium ion plant will be much too obvious and noticeable for the sensibilities of Northville. This proposal would fundamentally change Northville, which is needed, but it would not change it in a useful or positive way.

What will be done for fires when there is limited availability and access? Our fire department is small and volunteer, and will have actual humans and other emergencies to respond to. If they are busy spraying millions of gallons of water on burning batteries, it puts everyone around in immediate danger.

What will be done to keep the runoff from the water sprayed onto that inevitable fire, from entering the lake? The proposal speaks to keeping chemicals out of the ground water, but does nothing to address everything flowing directly into the lake across the ground surface.

There is no EAP plan developed yet. Who will be involved in creating this plan? What expertise and experience do they have with this specific and special Ed situation? Will it be completed before building is started?

The visual examples provided in the PDFs show that no road-side trees will be removed, no impact to any visible land, and even the Griff auto sign will still be standing. This seems incredibly unrealistic for the amount of trucks and machines that will be needed for building. This attempt at placating the public with unrealistic visuals, make

the entire project seem suspicious. There is real concern to this kind of project, but it feels like the non-local company behind it, is more interested in tricking the public and quietly moving forward without challenge, instead of addressing the realities.

Do the people that profit from this live anywhere near it? Will they even come to see any of its progress or know anything of the build site?

This has the feeling of some kind of cash-grab, quick action scheme, for an essentially faceless, dubious “energy” company, to make a lot of money quickly and then leave the locals to deal with the mess of it.

The proposal lists 4 items, which means these 4 items must be what the company thinks are the most important aspects. So from that we know there are safety and environmental concerns, the company hopes to fool the public into thinking it will be almost invisible in look, and most concerningly, the company knows, with certainty, that it is a huge impact for a short term gain. 1 of the 4 most important notes is a large document about how expensive and difficult it will be to get rid of it when it is no longer useful.

I do support progress and change. I love the idea of green energy and varying methods of future-i proven so I am not opposed to this project in principal. But having concerns not adequately answered and planned for, knowing this comes with real life negative impact to the environment and the appeal of the area, and that it is a short term plan with enormous cost to recover from, make this a very undesirable project.

I appreciate this process and the effort to collect feedback and input. I thank you for giving us an opportunity to have a voice on things that directly impact us. I am grateful for the APA and look forward to all the ways you will continue to help keep the Adirondacks beautiful. Thank you.
