For information: Earlier this spring DEC and the Office of Parks, Recreation and Historic Preservation announced the finalization of the 30x30 open space conservation strategies and methodology to enable New York State to reach its goal of conserving 30% of its lands and waters by the year 2030. DEC staff will provide an overview of the recently released strategies and methodology, which can be accessed here: <https://dec.ny.gov/nature/open-space/30x30>. The document outlines the State's scientific framework, criteria, and strategic approach to identify, measure, and advance conservation efforts. The final document reflects extensive collaboration with State agencies, local governments, Tribal Nations, landowners, conservation organizations, and community stakeholders.

DEC staff will provide an overview and history of its Conservation Easement Program.
